- 8. Tackling Anti-Social Behaviour remains a key priority within the Borough's Sustainable Community Strategy, One Darlington: Perfectly Placed and within the Crime and Disorder Reduction Partnership's Community Safety Plan 2008/11.
- 9. The Anti-Social Behaviour Strategy draws together some of the key activity the Council and its partners intend to deliver during the next year to make Darlington safer.
- 10. The strategy pulls together a range of activity being delivered across the Council, through Departmental Plans and activity being delivered through the Crime and Disorder Reduction Partnership's Anti-Social Behaviour Action Plan.

- 13. The core elements of the strategy were consulted upon as part of the development of One Darlington: Perfectly Placed and the Borough's Community Safety Plan. The refreshed strategy was widely circulated to Council Departments and the Crime and Disorder Partnership for input.
