10. DECLARATIONS OF INTEREST – There were no declarations of interest reported at the meeting.

11. SENIOR MANAGEMENT STRUCTURES – The Chief Executive submitted a report (previously circulated) to seek approval for changes to the Council's Senior Management structure relating to adults and children's services as a result of an imminent vacancy of key Chief Officer posts.

The submitted report stated that the Council, at its meeting on 17th July 2014, agreed changes to the management structures and roles within People Services, in response to the emerging collaboration with the Darlington Clinical Commissioning Group (DCCG). The submitted report advised of further changes required due to the new way of working, in addition to the impending loss of two key senior staff.

RESOLVED – (a) That a new post of Director of Adults and Children's Services be created at the grade detailed within the submitted report.

(b) That the posts of Director of People, Assistant Director Children, Families and Learning (re-designated as Service Director – Children's Services from September 2014), and Assistant Director Adult Social Care be deleted.

REASON – To ensure appropriate leadership and management of critical areas of Council services and statutory functions, and to enable progress to continue in delivering the Council's vision and Medium Term Financial Plan.

12. APPOINTMENT TO COMMITTEES 2015/16 - The Assistant Chief Executive submitted a report (previously circulated) to give consideration to the appointment of Members to the various committees for the 2015/16 Municipal Year, excluding the General Licensing, Licensing Act 2003 and Planning Applications Committees, the appointments to which were made at the Annual Meeting of the Council on 21 May 2015, and to request that any consequential amendments be made to the Council's constitution.
