To add the following to the Motion moved by Councillor A. J. Scott and seconded by Councillor Mrs. H. Scott:-

'and in light of evidence presented today, this Council calls upon the Darlington Clinical Commissioning Group to urgently revisit current proposals and confirm:-

- 1. That it will retain a full Accident and Emergency service at Darlington Memorial Hospital to ensure that the following risks are not realised:
 - (a) the health risks to patients of longer journey times to hospital for urgent treatment:

- (b) the risks and problems to relatives and carers, particularly those from low income households, of longer and costly journeys to see patients; and
- (c) the risks to already stretched social care services of unfunded proposals for out of hospital services; and
- 2. That it will retain a consultant-led maternity and paediatric service at Darlington Memorial Hospital
- 3. This Council asks Members of the Health and Partnerships Scrutiny Committee to use their full powers to evaluate and challenge the details published in the SPT as it moves forward.'
