- Councillor Bill Stenson was first elected to the Council on 13 May 1965. He had a break in service from May 1971 to June 1973 and was re-elected on 7 June 1973. On 6 June this year he completed 50 years' service as a Councillor for Darlington.
- As Members will be aware, Councillor Stenson has been suffering from ill health and Council, on 23 March 2017, agreed a six-month extension to his term of office as he had been unable to attend meetings since September 2016.
- 7. Councillor Stenson has subsequently resigned as a Councillor for the Mowden Ward, with effect from 21 September 2017, due to ill health (**See Appendix 1**).
