# GENERAL LICENSING COMMITTEE 13 NOVEMBER 2018

**L10. DECLARATIONS OF INTEREST** – There were no declarations of interest reported at the meeting.

**L11. MINUTES** – Submitted – The Minutes (previously circulated) of the meeting of the General Licensing Committee held on 16 October 2018.

**RESOLVED** – That the Minutes be approved as a correct record.

L12. RENEWAL OF LICENCE FOR PREMISES TO BE APPROVED AS A VENUE OR MARRIAGES AND CIVIL PARTNERSHIPS – ROCKCLIFFE HALL – The Assistant Director of Law and Governance submitted a report (previously circulated) to consider an application received from Rockliffe Hall Hotel for the renewal of a licence to be approved as a venue for Civil Marriages and Civil Partnerships in accordance with the provisions of the Marriage Act 1949 (as amended by the Marriage Act 1994); the Civic Partnership Act (2004); the Marriage and Civil Partnerships (Approved Premises) Regulations 2005; and the Marriage (Same Sex Couples) Act 2013.

The submitted report gave a summary of Rockliffe Hall as an approve venue; the designated rooms and maximum capacity; and a copy of the application was appended to the submitted report.

As part of the renewal process the application sought to approve two additional areas as a place where a Civil Ceremony could take place namely 'The Glasshouse' and the 'Rosebud Curious Cabin'. The Superintendent Registrar advised the Members that the Licensing Officer and the Building Control Manager had been consulted on the additional areas and no concerns had been raised.

**RESOLVED** – That approval be granted for the renewal of Rockliffe Hall, Hurworth, Darlington as an approved venue for the solemnisation of Marriages and Civil Partnerships in respect of the venue subject to the standard licence conditions and

that the maximum number of persons permitted to occupy ceremony rooms on the occasion of Civil Marriages or Civil Partnerships.

**L13. LICENSING FEES AND CHARGES FOR 2018-2019** – The Director of Economic Growth submitted a report (previously circulated) to invite Members to determine the licence fees relating to transport licensing and animal welfare licensing. The proposed fees had been based on the recovery of administering and where appropriate enforcing the relevant legislation relating to such licences.

It was reported that Full Council at its meeting on 28 January 2016 had delegated the setting of all fees and registrations that are within the remit of the General Licensing Committee to that Committee to enable in depth consideration to be given by Members in a specialist Committee.

The submitted report outlined the introduction of a 'licensing' scheme for home to school transport drivers and operators; the accordance with the Animal Welfare Act 2006 the introduction of the Animal Welfare (Licensing of Activities Involving Animals) Regulations on 1 October 2018; and a review of the Licensing Service.

The submitted report also outlined the review of the taxi licensing fees for the current financial year which showed that at the end of the last financial year the carry forward income for Hackney Carriages was £34,228 and £28,509 for private hire giving a total carry forward of £62,373. It was therefore proposed that all fees in respect of hackney carriage and private hire vehicles, drivers and operators remain for a third year at their current levels.

With regard to Animal Welfare Licence Fees a costings exercise in relation to the application processing and licensing and inspection of animal welfare premises had been carried out in order that the fees reflected the cost to the Council for providing this Service. The proposed fees were outlined in the submitted report and will be reviewed annually.

Members welcomed the report and in particular the introduction of a 'licensing' scheme for home to school transport drivers and operators to be implemented at the end of this financial year to ensure that drivers and operators who carry the most vulnerable members of the public are protected at all times.

#### **RESOLVED** – That Members of this General Licensing Committee:

- (a) approve that the taxi licensing fees continue at their current rate from 1 April 2019; and
- (b) approve the fees in respect of animal welfare licensing as detailed in the submitted report.

LGS12. PRIVATE HIRE DRIVER LICENCE APPLICATION FOR GRANT – REF 16/18 (EXCLUSION NOS 1 AND 7) – The Director of Economic Growth submitted a report (previously circulated) to give consideration to an application for the grant of a private hire driver licence in the light of previous convictions.

The driver attended the meeting and responded to Members questions in relation to the above, and to why they felt that they were a fit and proper person to hold a Private Hire Driver Licence

In reaching their decision, Members took into consideration the Council's Licensing Policy, which sets out the Council's stance on the Relevance of Convictions, Cautions and Endorseable Fixed Penalties and in assessing whether an applicant is a fit and proper person; and Section 51 (1)(a) of the Local Government (Miscellaneous Provisions) Act 1976.

During the meeting Members were made aware that the driver had been involved in three driving related incidents in 2016 and although they had a conviction for the September 2016 offence they were not prosecuted for the offences in February and August 2016 as the police officer present told the Sub-Committee that they had been unable to trace the driver within the 6 month time frame that they had to prosecute you, and therefore they could not take any further action.

After careful consideration Members decided to refuse the application as they did not feel that the driver was a fit and proper person to hold a Private Hire Driver Licence. They agreed that although the driver had not been convicted of the offences in February and August 2016, they admitted to the Sub-Committee that they had committed those offences. Members could therefore not accept the explanation that they had not received the letters from police regarding the incidents in February and

September 2016. The driver also did not disclose these incidents on their application form and one came to light when the Council conducted a check with the DVLA and the other two when the police officer at the meeting advised the Members and Members therefore felt that this indicated that the driver was not a fit and proper person to hold a licence.

**RESOLVED** –That the application be refused as the Committee did not consider the applicant to be a fit and proper person to hold a Private Hire Driver Licence.

# **Purpose of Report**

- To consider an application received from Darlington Borough Council for the renewal of a licence to be approved as a venue for Civil Marriages and Civil Partnerships in accordance with the provisions of:-
  - The Marriage Act 1949 (as amended by the Marriage Act 1994),
  - The Civil Partnership Act (2004)
  - The Marriage and Civil Partnerships (Approved Premises) Regulations 2005, and
  - The Marriage (Same Sex Couples) Act (2013)

## **Summary**

- 2. The Council Chamber has been an approved venue for Civil Marriages and Civil Partnerships for a number of years and has been the designated Register Office decommissioned marriage since the Register Office relocated into the Town Hall in October 2016. Its current licence is due to expire on 2 June, 2019.
- 3. The Council Chamber has proved a popular place for Civil Marriages and Civil Partnership and couples have a choice of either a small ceremony of up to 20 people in the Council Chamber Foyer or, for larger weddings, a ceremony in the Council Chamber of up to 70 guests. The Council Chamber Public Gallery is not licenced
- 4. As a previously approved venue for Marriages and Civil Partnerships the Council Chamber is considered to be suitable for approval as a venue for Marriages and Civil Partnerships, subject to the standard conditions and a limit on the number of people permitted to be present in the nominated rooms below.

#### Information

- 5. The Marriage Act 1949 (as amended by the Marriage Act 1994), the Marriages and Civil Partnerships (Approved Premises) Regulations 2005, and the Marriage (Same Sex Couples) Act 2103 permit a Local Authority to approve the use of certain premises as venues for Civil Marriages and Civil Partnerships. This Council is the appropriate Authority for premises within the Borough of Darlington.
- 6. A copy of the application submitted is attached as an **Appendix**. The renewal fee is not applied as the venue is a Darlington Borough Council venue.
- 7. In accordance with building control requirements, the applicant has confirmed:-

That a Fire Risk assessment has been carried out within the last 3 years which covers the proposed areas for use and occupancy.

That a Disability Risk Assessment has been carried out and that there are no access issues for persons attending ceremonies in the proposed areas for use and occupancy other than highlighted above.

8. The maximum number of persons permitted in each room is proposed as follows:-

The Council Chamber 70 guests
The Council Chamber Foyer 20 guests

#### **Legal Implications**

 This report has been considered by the Assistant Director, Law and Governance, for legal implications in accordance with the Council's approved procedures. There are no issues which need to be brought to the specific attention of Members, other than those highlighted in the report.

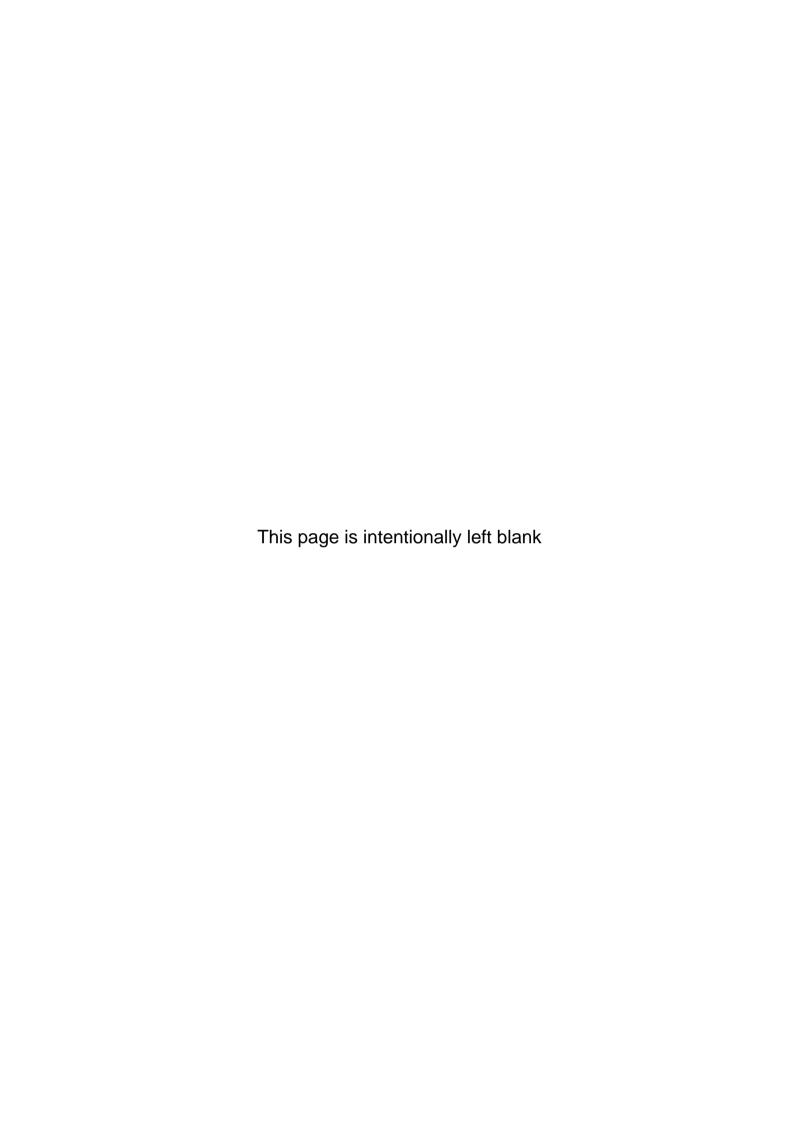

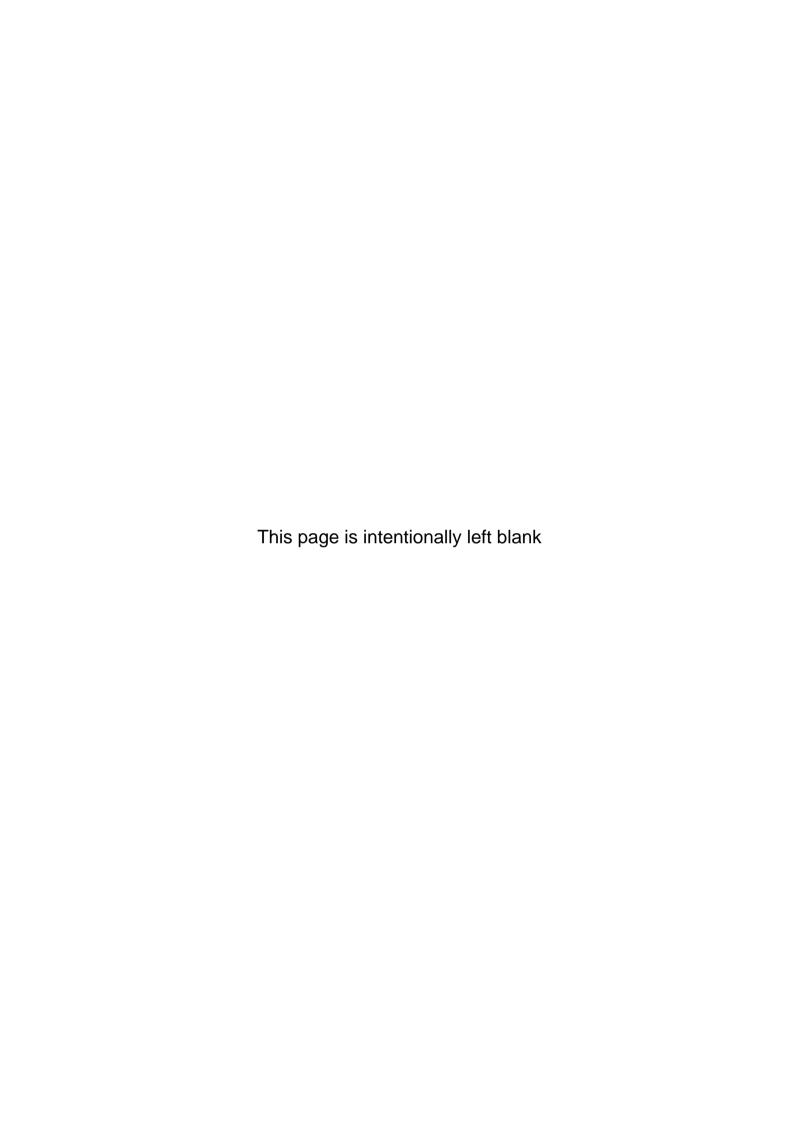

The Hippodrome Theatre is keen to become an approved premise for Civil Marriage and Civil Partnerships and whilst the number of ceremonies that will take place there will be relatively small in number, it will nevertheless be a welcome addition to the venues already approved for Civil Marriages and Civil Partnerships in Darlington and one which celebrates Darlington's history, identity and culture.
- The premises are considered to be suitable for approval as a venue for Marriages and Civil Partnerships, subject to the standard conditions and a limit on the number of people permitted to be present in the nominated rooms.
- 4. Subject to approval, a three year licence would be granted from the date of this Committee.

#### Information

- 5. The Marriage Act 1949 (as amended by the Marriage Act 1994), the Marriage and Civil Partnerships (Approved Premises) Regulations 2005 and the Marriage (Same Sex Couples) Act 2013 permit a Local Authority to approve the use of certain premises as venues for Civil Marriages and Civil Partnerships. This Council is the appropriate Authority for premises within the Borough of Darlington.
- 6. A copy of the application submitted is attached an **Appendix**. The application fee is not applied as the venue is a Darlington Borough Council venue.
- 7. Following receipt of the application, consultations have been undertaken with the following:-
  - (a) Licensing Officer, Darlington Borough Council; and
  - (b) Building Control Manager, Darlington Borough Council.
- 8. In accordance with building control requirements, the applicant has confirmed:-

That a Fire Risk assessment has been carried out within the last 3 years which covers the proposed areas for use and occupancy.

That a Disability Risk Assessment has been carried out and that there are no access issues for persons attending ceremonies in the proposed areas for use and occupancy other than highlighted above.

9. The maximum number of persons permitted in each room is proposed as follows:-

#### **Legal Implications**

#### Conclusion

12. Officers recommend that The Hippodrome Theatre, Parkgate, Darlington is a suitable venue for Civil Marriages and Civil Partnerships under the above legislation and that the licence be for a period of three years from the date of this Committee.

#### Recommendation

It is recommended that the application be granted for The Hippodrome Theatre, Parkgate, Darlington as an approved venue for the solemnisation of Marriages and Civil Partnerships in respect of the venue subject to the standard licence conditions and that the maximum number of persons permitted to occupy ceremony rooms on the occasion of Civil Marriages or Civil Partnerships should be as outlined in accordance with the Fire Officer's recommendations as detailed in paragraph 9 above.

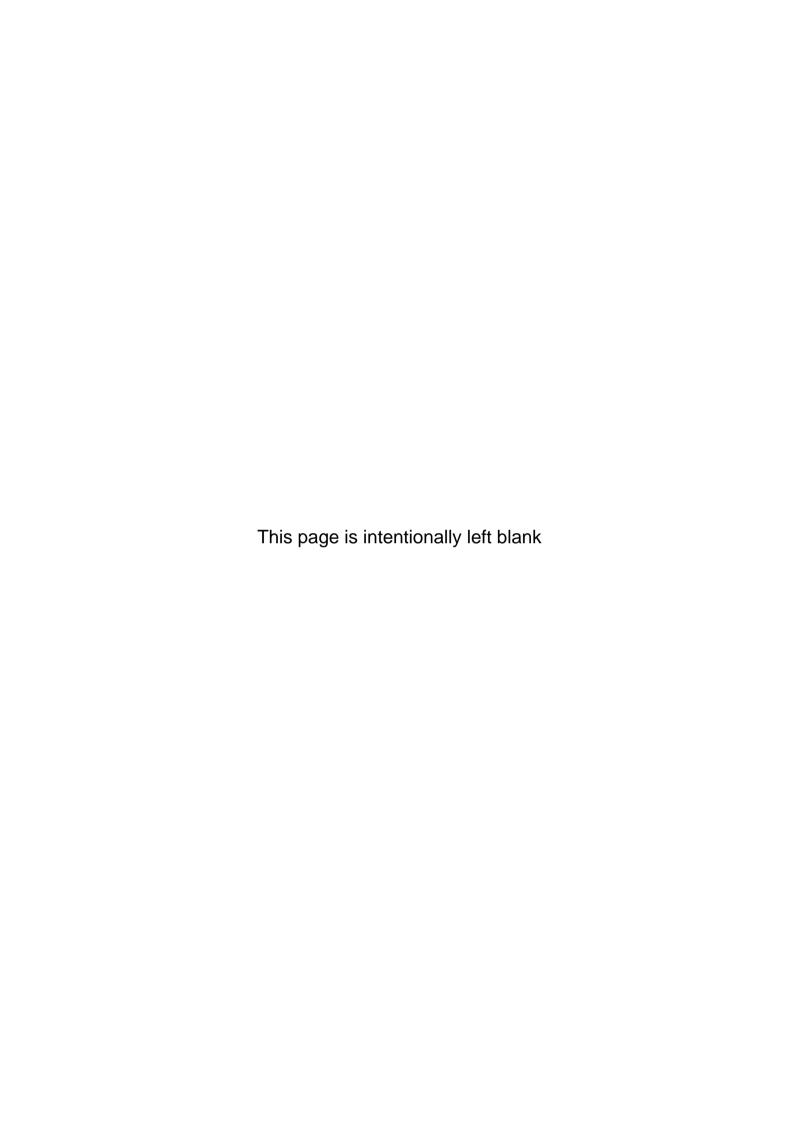

# APPLICATION FOR RENEWAL OF LICENCE FOR PREMISES TO BE APPROVED AS A VENUE FOR MARRIAGES AND CIVIL PARTNERSHIPS Redworth Hall Hotel, Redworth, Darlington

## **Purpose of Report**

- 1. To consider an application received from Redworth Hall Hotel for the renewal of a licence to be approved as a venue for Civil Marriages and Civil Partnerships in accordance with the provisions of:
  - The Marriage Act 1949 (as amended by the Marriage Act 1994),
  - The Civil Partnership Act (2004)
  - The Marriage and Civil Partnerships (Approved Premises) Regulations 2005, and
  - The Marriage (Same Sex Couples) Act (2013)

## **Summary**

- 2. Since 1994 Registration Districts have been able to approve other venues as an alternative venue to a Register Office which are largely hotels.
- 3. Redworth Hall Hotel is an established approved venue for Civil Ceremonies generating business for the Register Office and for local business, attracting couples who are marrying both the local area and from further afield.
- 4. There have been no issues with the venue which would adversely affect its application. The current three year licence as an approved venue is due to expire on 15th July, 2019 and the Committee is asked to consider an application for its renewal for a further three years.

## Information

 The Hotel has several areas within it designated as approved places where civil ceremonies can take place. A list of these designated rooms and capacities is attached as an **Appendix** with the renewal application form.

- 6. In practice most civil ceremonies take place in The Great Hall. The additional rooms currently approved as a place for civil ceremonies are to meet a customer request or to meet business continuity needs e.g. in the event of a particular area of the hotel being inaccessible in the event of urgent maintenance or another event.
- 7. As part of the renewal process a venue has the opportunity to review the places designated where a civil ceremony can take place to reflect its business needs. The application seeks to renew all of the rooms currently designated within the Hotel with the exception of the Surtees Suite as this area has been recently been redeveloped as part of the Hotel's sports and leisure facilities.
- 8. The renewal fee of £1,700 has been paid.
- 9. Following receipt of the application, consultation has been undertaken with the following:-
  - (a) Licensing Officer, Darlington Borough Council; and
  - (b) Building Control Manager, Darlington Borough Council
- 10. In accordance with building control requirements, the applicant has confirmed:-
  - That a Fire Risk assessment has been undertaken within the last three years which covers the proposed areas for use and occupancy.
  - That a Disability Risk Assessment has been undertaken and that there are no access issues for persons attending ceremonies in the proposed areas for use and occupancy other than highlighted above.
