#### LGS16 PRIVATE HIRE DRIVER LICENCE APPLICATIONS FOR GRANT AND REVIEW OF A HACKNEY CARRIAGE DRIVER LICENCE (EXCLUSION PARAGRAPHS 1 AND 7)

The Director Economic Growth and Neighbourhood Services submitted a report (previously circulated) to give consideration to an application for the grant of a Private Hire Driver Licence in light of previous convictions; and a review of a Hackney Carriage Driver Licence in light of non-compliance with statutory requirements.

**Ref 1/19** – To consider the grant of a Private Hire Driver Licence in light of previous convictions and a previous refusal of licence by this General Licensing Sub Committee on 1 March 2016.

The driver attended the meeting and responded to Members in relation to the above, and to why they felt that they were a fit and proper person to hold a Private Hire Driver Licence.

Members also heard from Durham Constabulary about a speeding offence the driver had committed in July 2018.

In reaching their decision, Members took into consideration the Council's Licensing Policy, which sets out the Council's stance on the Relevance of Convictions, Cautions

and Endorseable Fixed Penalties in assessing whether an applicant is a fit and proper person; the Council's Private Hire and Hackney Carriage Licensing Policy and Procedures; and Section 51(1)(a) of the Local Government (Miscellaneous Provisions) Act 1975.

After careful consideration Members decided to grant the Licence, although Members did express their concern about the driver's past behaviour but noted that the driver had appeared to have turned their life around.

**RESOLVED** – That the application for the grant of a Private Hire Driver Licence be approved.

**Ref 2/19** – To consider a review of a Hackney Carriage Driver Licence in light of using a vehicle to ply for hire without a licence being issued from this authority.

The driver attended the meeting and responded to Members in relation to the above, and to why they felt that they were a fit and proper person to hold a Private Hire Driver Licence.

In reaching their decision, Members took into consideration the Council's Licensing Policy, which sets out the Council's stance on the Relevance of Convictions, Cautions and Endorseable Fixed Penalties in assessing whether an applicant is a fit and proper person; the Council's Private Hire and Hackney Carriage Licensing Policy and Procedures; and Section 62(1) of the Local Government (Miscellaneous Provisions) Act 1975.

After careful consideration Members decided to permit the driver to retain their licence, however they were unimpressed by the conduct of the driver and urged them to be more organised in the future.

**RESOLVED** – That the Licence be retained and the driver be issued with a final warning letter in respect of future conduct and warned that if any further convictions, cautions, warnings or reprimands are received they would be referred immediately to the General Licensing Sub-Committee and it was unlikely that they would be permitted to retain their Licence.

The driver attended the meeting and responded to Members questions in relation to the above, and to why they felt that they were a fit and proper person to hold a Hackney Carriage Driver Licence.

In reaching their decision, Members took into consideration the Council's Licensing Policy which sets out the Council's stance on the Relevance of Convictions, Cautions and Endorseable Fixed Penalties in assessing whether an applicant is a fit and proper person; the Council's Private Hire and Hackney Carriage Licensing Policy and Procedures; and Section 61(1) of the Local Government (Miscellaneous Provisions) Act 1976.

After careful consideration Members decided to revoke the Licence for reasons that based on the evidence given to Members at the meeting it was not possible to

ascertain whether the allegations were true or not, however Members' primary concern is to safeguard taxi passengers; and felt that to allow the driver to retain their licence they could not be satisfied that they were a fit and proper person to hold such a licence based on the evidence given to Members at the meeting they could not be completely satisfied of this.

**RESOLVED** – That the licence be revoked with immediate effect under Section 61(1) of the Local Government (Miscellaneous Provisions) Act 1976

**Ref 4/19 –** To consider the grant of a Private Hire Driver Licence in light of previous convictions.

The driver attended the meeting and responded to Members questions in relation to the above, and to why they felt that they were a fit and proper person to hold a Private Hire Driver Licence.

In reaching their decision, Members took into consideration the Council's Licensing Policy, which sets out the Council's stance on the Relevance of Convictions, Cautions and Endorseable Fixed Penalties in assessing whether an applicant is a fit and proper person; the Council's Private Hire and Hackney Carriage Licensing Policy and Procedures; and Section 51(1)(a) of the Local Government (Miscellaneous Provisions) Act 1975.

After careful consideration Members decided to grant the licence and depart from the Council's Policy for an applicant to be free of any convictions for at least five years as despite your convictions they felt that you were a fit and proper person to hold such a licence.

**RESOLVED** – That the licence be granted with a warning in respect of future conduct and the driver be warned that if any further convictions, cautions, warnings or reprimands are received they would be referred immediately to the General Licensing Sub Committee for review of their licence and that this may result in the licence being revoked.

**Ref 5/19** – To consider the grant of a Private Hire Driver Licence in light of previous convictions and concerns over their behaviour towards the Licensing Team staff.

The driver attended the meeting and responded to Members questions in relation to the above, and to why they felt that they were a fit and proper person to hold a Private Hire Driver Licence.

In reaching their decision, Members took into consideration the Council's Licensing Policy, which sets out the Council's stance on the Relevance of Convictions, Cautions and Endorseable Fixed Penalties in assessing whether an applicant is a fit and proper person; the Council's Private Hire and Hackney Carriage Licensing Policy and Procedures; and Section 51(1)(a) of the Local Government (Miscellaneous Provisions) Act 1975.

After careful consideration Members decided to refuse the application as Members could not be assured that the applicant was a fit and proper person to hold such a licence and they were not confident that after speaking with the applicant they could behave appropriately and control their temper and have the confidence that they would have the ability to deal with difficult situations as a taxi driver.

Also with regard to the applicants convictions, the Council's policy is that the application be free from conviction for five years before a licence is granted however, Members may have been minded to depart from that policy had the applicant displayed a different demeanour and attitude at the Committee meeting.

**RESOLVED** – That the applicant for a Private Hire Driver Licence be refused.

#### The Kings Hotel, Priestgate, Darlington

#### Purpose of Report

- To consider an application received from Station Hotels Ltd on behalf of The Mercure Darlington Kings Hotel, Priestgate for the renewal of its licence to be approved as a venue for Civil Marriages and Civil Partnerships in accordance with the provisions of:-
  - The Marriage Act 1949 (as amended by the Marriage Act 1994),
  - The Civil Partnership Act (2004)
  - The Marriage and Civil Partnerships (Approved Premises) Regulations 2005, and
  - The Marriage (Same Sex Couples) Act (2013)

#### Summary

- 2. The Kings Hotel has been an approved venue for Civil Marriages and Civil Partnerships for a number of years and Its current licence is due to expire on 4 June, 2019.
- 3. As a previously approved venue for Marriages and Civil Partnerships the Kings Hotel, Priestage is considered to be suitable for approval as a venue for Marriages and Civil Partnerships, subject to the standard conditions and a limit on the number of people permitted to be present in the nominated

mit on the number of people permitted to be present in the nominate rooms below.

#### Information

- 5. The Marriage Act 1949 (as amended by the Marriage Act 1994), the Marriages and Civil Partnerships (Approved Premises) Regulations 2005, and the Marriage (Same Sex Couples) Act 2103 permit a Local Authority to approve the use of certain premises as venues for Civil Marriages and Civil Partnerships. This Council is the appropriate Authority for premises within the Borough of Darlington.
- 6. A copy of the application submitted is attached as an **Appendix**. The renewal fee of £1700.00 had been received.
- 7. The applicant has confirmed within the application :-
  - 1. That there are no planning issues which would adversely affect this application and its continued use as an approved venue for Civil Marriages and Civil Partnerships.
  - 2. That it has adequate and current fire precautions in consideration of it being a commercial hotel accessed by members of the public.
  - 3. That there are no equality issues which would prevent access or use by a member of the public.

Under its current licence the venue has three rooms where ceremonies can take place; The Ballroom; The Pullman Suite and the Locomotion Suite. The applicant has chosen in their application not to include the Locomotion Suite as a designated place where future ceremonies to take place as this area is now designated as a public bar and restaurant. The applicant wishes to continue to use the Ballroom and the Pullman Suite and designated places for ceremonies. Ceremonies regularly take place in these two designated rooms.

8. The applicant does not seek any increase the maximum number of persons permitted in each room and which is proposed as follows :-

The Ballroom – 180 guests The Pullman Suite – 60 guests

#### **Legal Implications**

9. This report has been considered by the Assistant Director, Law and Governance, for legal implications in accordance with the Council's approved procedures. There are no issues which need to be brought to the specific attention of Members, other than those highlighted in the report.

#### Section 17 of the Crime and Disorder Act 1998

10. The contents of this report have been considered in the context of the requirements placed on the Council by Section 17 of the Crime and Disorder Act 1998, namely, the duty on the Council to exercise its functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area. It is not considered that the contents of this report have any such effect.

#### Conclusion

11. Officers recommend that the Kings Hotel, Priestgate, Darlington is a suitable venue for Civil Marriages and Civil Partnerships under the above legislation and that the licence be renewed for a period of a three years up to 4 June 2023.

#### Recommendation

12. It is recommended that the application for renewal be granted for The Kings Hotel, Priestage, Darlington as an approved venue for the solemnisation of Marriages and Civil Partnerships in respect of the venue subject to the standard licence conditions and that the maximum number of persons permitted to occupy ceremony rooms on the occasion of Civil Marriages or Civil Partnerships.

The Blackwell Grange Hotel is a well established and popular venue for Civil Marriages and Civil Partnerships and there have been no issues or concerns with the venue for the duration of its current licence which would adversely affect this application.

8. The applicant does not seek any increase to the maximum number of persons permitted in each room and which is proposed as follows :-

The George Allan Suite – 130 guests The Bruhenny Suite – 300 (formerly known as the Jacobean Suite) The Havelock Restaurant – 150 guests The Gazebo – 6 guests The Gazebo facilitates outside weddings at the venue. The Gazebo is a permanent structure which cannot be relocated and meets the requirements as a designated place for civil marriages and civil partnerships in terms of being in a permanent location should a potential objector need to locate the wedding. The Gazebo is the place of the signing of the Marriage or Civil Partnership Register and where the couple, witnesses and registrars remain for the ceremony. An unlimited number of guests can observe the ceremony from outside of the Gazebo however they do not form part of the legal component of the ceremony. A photograph of the Gazebo is attached an an **Appendix.** 

#### Legal Implications

9. This report has been considered by the Assistant Director, Law and Governance, for legal implications in accordance with the Council's approved procedures. There are no issues which need to be brought to the specific attention of Members, other than those highlighted in the report.

#### Section 17 of the Crime and Disorder Act 1998

10. The contents of this report have been considered in the context of the requirements placed on the Council by Section 17 of the Crime and Disorder Act 1998, namely, the duty on the Council to exercise its functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area. It is not considered that the contents of this report have any such effect.

#### Conclusion

11. Officers recommend that the Blackwell Grange Hotel Grange Road, Darlington is a suitable venue for Civil Marriages and Civil Partnerships under the above legislation and that the licence be renewed for a period of a three years up to 22<sup>nd</sup> November, 2023.

#### Recommendation

12. It is recommended that the application for renewal be granted for The Blackwell Grange Hotel, Grange Road, Darlington as an approved venue for the solemnisation of Marriages and Civil Partnerships in respect of the venue subject to the standard licence conditions and that the maximum number of persons permitted to occupy ceremony rooms on the occasion of Civil Marriages or Civil Partnerships.



The requirements for approved premises are established by the Marriage and Civil Partnerships (Approved Premises) Regulations 2005 and Amendment Regulations 2011 (referred to in these notes as the Regulations). It is these that the authority must apply when considering an application for approval.

The application must be made by the proprietor or trustee of the premises. When made on behalf of a limited company, or other incorporated business there should be a separate statement of the names and addresses of all the directors.

The premises must fulfil the following standard requirements in the Regulations:

1. Having regard to their primary use, situation, construction and state of repair, the premises must, in the opinion of the authority, be a seemly and dignified venue for the proceedings.

2. Subject to any exemptions in the Equality Act 2010 (see paragraphs 2.7 -2.11 of this guidance), the premises must be regularly available to the public for use for the solemnization of marriages and the registration (formation) of civil partnerships.

3. The premises must have the benefit of such fire precautions as may reasonably be required by the authority, having consulted with the fire and rescue authority, and such other reasonable provision for the health and safety of persons employed in or visiting the premises as the authority considers appropriate.

4. The premises must not be a register office, but this paragraph does not apply to premises in which a register office is situated provided that the room which is subject to approval is not the same room as the room which is the register office.

5. The room or rooms in which the proceedings (marriage or civil partnership) will be held if approval is granted must be identifiable by description as a distinct part of the premises.

#### The premises must also fulfil the authority's following requirements:

In considering the suitability of premises as a venue, the authority will have due regard to the following guidance from the Registrar General:

1. The law relating to "approved premises" is intended to allow proceedings to take place regularly in hotels, stately homes, civic halls, religious premises and similar premises without compromising the solemnity of the occasion.

2. Premises are defined in the Regulations as a permanently immovable structure comprising at least a room, or any boat or other vessel which is permanently moored. Premises not within the meaning of this definition, such as the open air, a tent, marquee or any other temporary structure and most forms of transport, will not be eligible for approval.

3. The premises must be a seemly and dignified venue for the proceedings, which must take place in an identifiable and distinct part of those premises. The primary use of a building would render it unsuitable if that use would demean any proceedings or bring them into disrepute.

4. The premises must not be any part of a register office on the plan submitted by the authority and approved by the Registrar General under the Registration Service Act 1953. Any rooms in the same premises as the register office that aren't on this plan, e.g. a council chamber in the same town

hall, can be approved but a room in a register office cannot be approved. However, an authority can set its fee for attending a marriage or civil partnership on approved premises at the same level as the prescribed fee for a marriage or civil partnership in a register office.

5. The requirement that the premises must be regularly available for use by the public will preclude a private house from being approved.
