LA4 LICENSING PRINCIPLES FOR GAMBLING ACT 2005

The Director of Economic Growth and Neighbourhood Services submitted a report (previously circulated) for Members to give consideration to a Draft Statement of Licensing Principles for the Gambling Act 2005.

The Gambling Act 2005 gives responsibility to the Gambling Commission for the issue of Operating Licences in respect of businesses offering gambling and also for the issue of Personal Licences for those employed in the business of gambling; and the 2005 Act requires all Local Authorities to prepare, consult on and publish a Gambling Policy.

It was noted that the first policy was approved by Members at the Council meeting held on 23 November 2006 and took effect on 31 January 2007 and has been revised every three years and was last revised by Council in November 2005 for publication on 31 January 2016. The Policy was therefore due to be revised.

The submitted report advised that the Council currently licensed 12 Betting Shops

and 26 Licensed Clubs and Pubs for the provision of gambling. The 2005 Act requires Local Authorities to follow the Guidance and Codes of Practice issued by the Gambling Commission and also the Council's own policy statement.

It was also noted that the policy had remained largely unchanged and a widespread consultation exercise had been undertaken over a six week period from 11 February to 23 March 2019 with the Responsible Authorities, the gaming industry, the leisure industry and organisations dealing with problems arising from gambling.

It was reported that two responses had been received in respect of the revised document one from Darlington Borough Council's Public Health highlighting the harms gambling can cause and the other from the Association of British Bookmakers highlighting that the number of betting shops had declined and some regulatory changes such as planning in 2015 had had an adverse effect.

RESOLVED – That the revised Licensing Principles be approved prior to its submission to Full Council.

UPDATE RELATING TO LICENSING ACT POLICY REVIEW

SUMMARY REPORT

Purpose of the Report

1. To update Members with the current position of the Licensing Act Policy Review due in January 2021 in light of the Covid-19 pandemic.

Summary

- 2. The Licensing Act 2005 requires that its Statement of Licensing Policy is reviewed every five years and Darlington Borough Council's policy is scheduled to be renewed in January 2021. Work had commenced on this review early in the year, however the Covid-19 regualtions have had an enourmous impact on the hospitality trade, particularly those with premises licences and many have been compelled to close. Recent partial relaxation of the Covid-19 Regulations has seen the dynamics of drinking alcohol change considerably, which may have an impact for many years to come.
- 3. At a recent meeting of the North East Strategic Licensing Group (NESLG), concerns were expressed that due to the closure of many licensed premises and the fact it will take many months to establish business anywhere close to what had been experienced before the Covod-19 lockdown, it will be impossible to adequately consult with an industry that has been deeply damaged and may never recover to the level it used to operate.
- 4. With these concerns expressed, clarity was sought by the Local Government Association (LGA) with the Home Office, whether the scheduled Licensing Act Policy Reviews could be delayed to such a time that adequate consultation could take place with the hospitality industry for new policies to be developed. Under the current circumstances this is considered acceptable by the LGA, provided work is progressed once some level of normality has returned.
- 5. It is proposed that a decision is made to maintain Darlington's current Licensing Act Policy until the imprementation of a revised policy in April 2021. This will afford the Licensing Authority an opportunity for meaningful consultations with the hospitality

industry as it gradually regains some degree of normality, whilst being aware that there may be further local 'lockdown' requirements. Other Responsible Authorities and stakeholders who would normally be heavily involved in the consultation process are also in a similar position where they are currently not able to provide a full service for the consultation.

Recommendations

6. It is recommended that :-

The Licensing Committee retain the current Licensing Act Policy until April 2021 to allow sufficient consultation time with the hospitality trade and stakeholders once Covid-19 Regulations have been sufficiently relaxed.

Reasons

7. The recommendations are supported by the following reason:-

To provide a pragmatic and fair approach to all those working within the alcohol arena, which is in a current state of transition, to ensure a full, meaningfull consulation process takes place for the public to continue to be safe within the Borough of Darlington.
