#### **DOLPHIN CENTRE REPAIRS**

#### SUMMARY REPORT

## **Purpose of the Report**

1. To request Council approve cabinets recommendation to Council to vary the capital budget for 2023/24 by £400K and release the capital to enable repairs to the toddler pool and retaining wall at the Dolphin centre.

### Summary

- 2. A Special Cabinet meeting was convened on 11 August 2023 to consider extending the Dolphin Centre Pool project to undertake additional works. Approval was received to progress areas of work in the vicinity of the changing area to secure the benefits identified in the report.
- 3. In securing the urgent approval from Cabinet the benefits to be secured from continuity of the current project are being progressed and the acceleration is advantageous from a financial, operational and customer perspective.
- 4. The report to the special cabinet meeting identified that further areas would also need to be considered on a similar basis, once the outcome of investigations had been completed and a further report would be brought to Cabinet and Council for consideration of further works in the current extended project.
- 5. The toddler pool area and the retaining wall investigations have been completed and cabinet considered a report on 5 September outlining the works proposed to these areas which are outlined in the main report. These areas were highlighted to Members in the special cabinet report as needing work in a revised time frame of two years.
- 6. The benefits of undertaking these works as part of the current project outlined in the special cabinet meeting are relevant to these works. The main benefits are outlined in the main report, but essentially undertaking the works as part of the current project will allow works to be undertaken in parallel, secure benefits from the continuity of the project and be advantageous from a financial, operational and customer perspective.

7. The approval of these further works would ensure as much of the works can be undertaken in parallel in as shorter period as possible to minimise the impact on customers and provide certainty going forward.

8. These further works will not impact on the timescales for the main pool to re-open (scheduled for January), as the area affected can be boarded off. In the meantime, swimming lessons and a timetable of lane swimming, family sessions and water aerobics are continuing in the training pool.

#### Recommendations

- 9. It is recommended that Council:-
  - (a) Vary the Capital Budget for 2023/24 by £400K and release the capital to accelerate the repairs in the Dolphin Centre that are identified in this report as an extension to the current project.

#### Reasons

- 10. The recommendations are supported by the following reasons:-
  - (a) To enable all the essential works are carried, meaning the toddler pool will not have to be closed for repairs in 18 months and that the toddler pool can be reopened at the earliest opportunity.
  - (b) To address structural issues within the base of the retaining wall in the plant room.
  - (c) Undertaking all the works that have been identified as needing repair within 2 years as part of the current project could save cost increases arising from construction inflation and lost income of up to £200K when compared to re-starting a project in 18 months' time.

## **MAIN REPORT**

## Background

- 11. The Dolphin Centre provides an excellent range of health and wellbeing activities as well as a key leisure and social venue in the town centre. The Dolphin Centre's popular swimming pool is currently undergoing structural repairs. This is part of an ongoing programme of work to ensure the building, which is more than 40 years old, continues to be fit for the 21st Century.
- 12. As the role of town centres continue to change with greater emphasis on leisure and social activities, the contribution the Dolphin Centre makes to the town centre will continue to increase. Its town centre location contributes significantly to the town centre footfall and vice versa. There are strong links to the Council Plan objectives and all the Council's portfolios, particularly Health and Economy.
- 13. Members approved additional works at a special Cabinet meeting on 11 August 2023. The area of the works approved are shown as Phase 2a on the plan at **Appendix 1.**

- 14. At the time of the special Cabinet meeting the investigations and options on the toddler pool area and the retaining wall in the plant room had not been completed. Members were advised a further report to Cabinet and Council would be forthcoming to consider the repairs for Phase 2b shown on the plan at **Appendix 1**.
- 15. Following the completion of the investigation and feasibility works Cabinet considered a report on 5 September 2023 which outlined the further work required: -
  - (a) The work to the toddler pool (shown as Phase 2b at Appendix 1) will require removal of tiles, exposure of concrete structure and the joints to make repairs to ensure the integrity of the structure. It is proposed to return the area to a similar format, with some updating of play features, removal of some of the original fixed features and steps that will improve overall safety of the facility. The pool has been a great asset over the years, with children enjoying playing and gaining water confidence. Where possible existing features will be retained alongside new additions to improve the facility.
  - (b) The investigations into the retaining wall deterioration looked at the drainage outside the Dolphin Centre to establish whether there were any leaks in the system impacting on the structure, findings suggest the drainage is not a cause, but further localised investigations are planned, therefore the deterioration of the retaining wall within the plant room is likely to be associated with the conditions in the plant room and age of the structure. A localised repair within the plant room is required to prevent further deterioration and to ensure the integrity of the structure.
- 16. The above repairs were identified at the special cabinet meeting as needing work in a revised time frame of two years, which would mean starting a new project within 18 months. Therefore, the benefits of undertaking these works as part of the current project that were outlined at the special cabinet meeting are also relevant to these works. The main benefits being:
  - (a) Extend current contracts, skills and arrangements as a continuation of the current project will save on preliminary work and re-mobilisation work and costs.
  - (b) Avoidance of further deterioration and risk.
  - (c) Avoidance of further construction inflation.
  - (d) Continue the arrangement with existing pool closure that are familiar to customers.
  - (e) Communications will be clearer than having to close again in a short period of time and provide certainty for customers.
  - (f) Saving of structural engineering monitoring costs in Area A over the 18-month period.
- 17. At the meeting of Cabinet on 5 September 2023 it was recommended that further funding be approved to undertake works on the toddler pool and the retaining wall as part of the current extended project. Cabinet approved the additional works identified in the report and agreed a report be progressed to Council to seek approval to vary the capital budget for 2023/24 by £400K and release the capital to enable repairs to the toddler pool and

- retaining wall at the Dolphin centre. If Council approve the budget variation work would commence as soon as practicably possible in parallel with the original works as soon as practicably possible.
- 18. Options will be explored to open the main pool and changing as soon as practicably possible, once the main pool works and changing area frontage are completed, even if this means the toddler pool is completed behind hoardings. The key challenge will be to have the demolition work completed prior to retiling phase 1 area.

#### **Finance and Governance**

- 19. Cabinet have delegated approval to vary the capital budget by £500k per year, of which £490k was agreed at the Special Cabinet meeting on 11 August 2023 to progress the works shown as Phase 2a in Appendix A.
- 20. At the Cabinet meeting of 5 September 2023, it was agreed to progress the works shown as Phase 2b and works to the retaining wall, and that Council approval be sought to vary the Capital Budget for 2023/24 by £400K to accelerate these repairs as an extension to the current project.
- 21. The £400k of works identified in this report will be funded through prudential borrowing with estimated annual borrowing cost of £26.4k over 30 years. This borrowing will be funded from the ongoing efficiency programme and development of further business opportunities. The Mechanical and Electrical upgrade programme previously approved will drive efficiency, with new building management systems and replacement of old equipment with more reliable and efficient equipment meaning less expensive reactive repairs. Feasibility work is also progressing on energy saving initiatives as part of the Council's Climate action plan.
