Eligibility - you will not be eligible if you:-

- a) are under 18 years of age;
- b) are detained under the Mental Health Act 1983;
- c) are bankrupt or disqualified under the Company Directors Disqualification Act or an order made under section 429(2)(b) of the Insolvency Act 1986;
- d) have been removed from the office of a charity trustee or trustee for a charity by an order made by the Charity

Commissioners or the High Court on the grounds of any misconduct or mismanagement or, under section 7 of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990, from being concerned in the management or control of anybody

- e) are included in the list of teachers or workers prohibited or restricted from working with children or young persons;
- f) have been disqualified from being an independent school proprietor, teacher or employee in any school by an Independent School Tribunal or by the Secretary of State;
- g) have in the previous five years (or since becoming a governor) been sentenced to three months or more in prison (whether this was suspended or not) without the option of a fine;
- h) have in the previous 20 years been sentenced to imprisonment for two and a half years or more:
- i) have at any time been sentenced to imprisonment for five years or more;
- j) have been fined for causing a nuisance or disturbance on school premises during the five years prior to, or since, appointment or election as a governor.
- k) are subject to a disqualification order under the Criminal Justice and Court Services Act 2000
